Spud 12 1/4" hole on 7-20-06. Run 8-5/8" 24# J-55 casing. Land @ 131', float collar @ 88'. Cement w/100 sx Type 5 cement w/3% CaCl2 w/1/4# celloflake/sx (134 cu ft total slurry). Displace w/6 bbls water. Circulate 3 bbls cement. NU BOP. Pressure test casing to 770# for 30 mins, held.
