XTO Energy Inc. plans on repairing casing failure from 252' - 267' by either backing off or cutting off 7-5/8" casing between 300' - 350'. New 7-5/8" csg will be run into well and screwed into existing casing or tie to existing casing with Bowen casing patch. The repaired casing will be pressure tested to 500 psig. This procedure was approved by Jim Lovato on 6/25/03.
