Perf PC @ 3430'-40', 3442'-44', 3447'-54', 3473'-77', 3493'-94', 3496'-99', 3508'-12' w/2-0.35" spf. Total 62 holes. Broke down PC w/500 gal 7-1/2% HCL acid & 93 perf balls. Fraced PC w/134,102# sand in 75Q slick foam. Cleaned out after frac & tested PC on 7/25/06 on 1/2" choke @ 22 psi for 231 MCF/D. Set RBP @ 3380'.

Perf Fruitland Sand @ 3345'-52' w/4-0.34" spf. Total 28 holes. Fraced FRTS w/40,000# sand in 75Q slick foam. Cleaned out after frac & tested FRTS on 7/29/06 on 1/4" choke for 30 psi & 66 MCF/D. Retrieve RBP @ 3380' & TOH. Landed 2-7/8" 6.5# J-55 tbg @ 3436' w/notched collar & SN on bottom.
