Cement with 100 sks Class B, 2% CaCl2, 1/4#/sk flocele (118 cu.ft.). Plug down @ 4:30 pm on 07/13/06. Circulate 5 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing and BOP to 600 psi - ok.
