

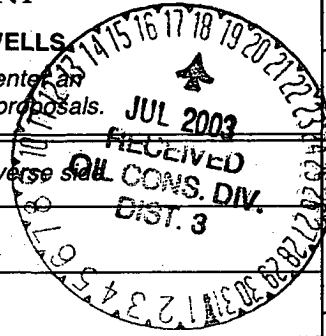

XTO Energy Inc. plans to squeeze casing per following steps:

Perforate 2 squeeze holes @ 6320'. Establish circulation out the 4-1/2" x 7" casing annulus. PU & TIH w/cement retainer & tbq. Set retainer 20' above squeeze holes. Squeeze w/sufficient cement volume (BJ prem Lite w/6% gel, 2% Phenoseal, 0.2% CD-32, 0.5% FL-52 & 1/4#/sx celloflake (mixed @ 12.5 ppg & 2.01 cuft/sx, 40% excess for open hole)) to bring TOC to 3650'. Sting out of retainer & wash up. TOH w/tbq. WOC 12 hrs. Run CBL to find TOC. If OK, DO cement & cement retainer. Proceed w/completion.
