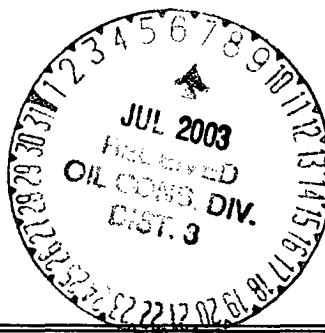

A production string of 2-3/8" tubing set with the end of tubing at 7942' and 1.78" "R" nipple at 7938'. The well was then turned to sales as a downhole commingled Dakota/Mesa Verde.
