Cmtd w/420 sxs Premium Lite FM w/3% calcium chloride, 0.25 pps celloflake, 5 pps LCM-1, 0.4% fluid loss, 0.4% sodium metasilicate (895 cu. ft.). Tail w/ 90 sxs Type III cmt w/1% calcium chloride, 0.25 pps celloflake, 0.2% fluid loss (124 cu. ft.). Circ 35 bbls cmt to surface. WOC. PT BOP & csg to 1500 psi/30 mins, OK. Drilling ahead.

6/25/03 Drill to TD @ 3647'. Blow well clean. TOOH. TIH, underream 6-1/4" hole @ 3395-3535'.

6/26/03 Underream @ 3535-3567'. Blow well. TOOH.
