Unable to press test 5-1/2" prod csg & 2nd plug. Pumped wtr dwn csg. SD. Ran temp survey fr/0' - 4920'. Temp survey indicated possible leak @ stage tool @ 4050'. RDMO WL & pmp trks. SWI.

XTO Energy Inc. proposes to repair casing leak as follows:

MIRU completion rig. TIH w/tbg & pkr. Confirm leak @ stage tool. Squeeze the leaking stage tool with approximately 100 sx cement. DO sqz and pressure test the casing. RDMO completion rig.

- Pressure test sqz. to a minimum of 500# for 30 minutes.
