Cement with 650 sks 65/35 Class G poz, 6% gel, 10#/sk gilsonite, 1/2#/sk floccle 2% CaCl2 tailed by 125 sks Class G, 5#/sk gilsonite, 1/4#/sk sk floccle (1429 cu.ft.). Plug down @ 10:15 am on 08/13/06. Circulate 50 bbls cement to surface. RD Halliburton. WOC. NU BOP. Test casing & BOP to 1200 psi - ok.
