RU & rn GR/CCL/CBL from PBTD (810') to surface, good cem to surface. PT csg to 2500 psi w/rig pump, ok. Perf Fruitland Coal w/3-1/8" csg gun, 4 spf, 120 deg phasing, 634'-654' (20', 80 holes) - all shots fired.
