1. MIRU. Kill well. ND wellhead. Fish 1" tubing and lay down.
2. Install new casinghead. NU BOP.
3. TIH with 6.25" bit on a 4.50" workstring. Drill out to 1773'. Condition hole to run casing. TOH.
4. Run open hole logs.
5. Run 4.50" 11.6# J-55 casing to TD. Cement back to surface and WOC.
6. Run cased hole log from TD to 1500'. Selectively perforate the Pictured Cliffs formation.
7. Fracture treat the PC with a 70Q foam treatment.
8. Clean out to PBTD. Run 2.375" tubing landed @ the bottom perf.
9. Set up compressor.
10. Install new separator and hook up to line.
11. Turn back on to production.
