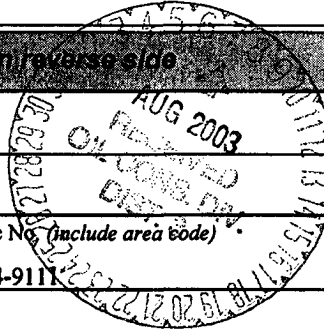

Ran centralizers on the bottom 3 joints including shoe joint. Cemented with 188 sks 15.8# Class G Cement with 2% CaCl2, .25 lb/sk D29 Cellophane, yield 1.16. Circulated 18 bbls cement to surface. WOC cement 12 hours.

7/30/03 - Pressure tested casing to 750 psi for 30 minutes. Held O.K. Tagged cement @ 233'.
