On 7/26/03 drilled 6 1/4" hole and ran 4 1/2" J-55, 10.5# casing and landed @6200' KB. KB = 13'0". Ran centralizers on the bottom 3 joints including shoe joint, then every 400' thereafter. Pumped 200 sks 50/50 G:Poz 4% Gel, .25#/sk D29 Cello Flake, 5#/sk Gilsonite, 2.5#/sk Phenoseal, 13.0# cement, yield 1.43. Plug down held to 1200 psi.

CBL and PSI test will be run at a later date.
