Drilled 8 3/4" hole and ran 7", J-55, 23#, LT&C casing and landed @ 3950' KB. KB = 13'0". Ran centralizers on the bottom 3 joints including shoe joint, then every 400 thereafter. Also ran 2 turbulizers at the base of the Ojo and the other up in the Ojo. Pumped lead cement of 360 sks 9.51# LiteCrete cement, with .25#/sk Cellophane, 2#/sk Cement, 2% Gilsonite, and 5#/sk Phenoseal, yield 2.52. Tailed with 100 sks 13.5# 50/50 G:Poz 2% Gel, .25/sk D29 Cellophane, and 5#/sk Phenoseal, yield 1.30. Circulation was held throughout the job, but no cement to surface. Ran Blue Jet Temperature Survey, and found TOC @ +/- 290'. Discussed with Charlie Perrin and Steve Hayden with the OCD before proceeding. WOC 17 hours. Pressure tested casing to 1000# for 30 minutes, held O.K.
