TIH & drill up CIBP @1618'. Tag plug @1226' & push to 1690'. Clean out wellbore. Tih & land 2 3/8" tbg @ 1642'. 7/10/06 Rig Down move off location.

Well is capable of down hole commingling. Waiting on compressor.
