1/30/06: Spud well. Drill 12-1/4" hole to 283'. Landed 8-5/8" 24# J-55 casing @ 283'. Cemented with 200 sacks (236 cf) STD cement with 2% CaCl<sub>2</sub>. Circulate cement to surface.

Drill 7-7/8" hole to 3664'. Landed 5-1/2" 15.5# J-55 casing on 2/4/06 @ 3664' with float collar @ 3642'. Cemented with 500 sacks (980 cf) 65/35 STD POZ cement with 6% gel, 10# gilsonite and 1/2# flocele. Tail with 150 sacks (219 cf) 50/50 STD POZ cement with 3% gel, 0.5% Halad 9, 5# gilsonite, 1/4# flocele, 0.2% CFR3, 0.2% Super CBL. Circulate 20 bbls cement to surface. Plan to pressure test and run CBL during completion operations.
