Brokedown perfs with 250 gallons 7-1/2% HCL acid. Fraced PC w/80,000# sand in 75Q foam. Clean out after frac. Tested PC on 3/1/06 on 1/8" choke for 4 hours @ 400 psi and 144 MCF/D. Landed 2-3/8" 4.7# J-55 tubing @ 3458'. Released rig 3/2/06. Completed as a single PC gas well.
