Drilled 12 1/4" hole to 294' on 6/17/06, set 9 jts of 9 5/8", H-40, ST&C, 32.3# casing at 285'. Cemented w/200 sx (42 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 25 bbls of cement to surface. Test casing to 750 psi.

Drilled 8 3/4" hole to 3,300' on 6/22/06, set 74 jts of 7", J-55 LT&C, 23# casing at 3,295'. Cemented lead w/550 sx (144 bbls) 50/50 POZ cement w/3% Gel, 5# Gilsonite, 1/4# Flocele, 0.1% CFR 3, 0.4% Halad 344 and tail w/75 sx (16 bbls) STD "B" cement w/0.4% Halad 344. Circulated 25 bbls of cement to surface. Tested casing to 1,500 psi.

Drilled 6 1/4" hole to 3,660' TVD on 7/20/06. Underreamed hole to 11" from 3,505' to 3,660'. Utilized natural and air assisted surges to remove near wellbore material. On 8/9/06, set 9 jts 5 1/2" 15.5, J-55 liner at 3,659' with liner hanger at 3,265'. Perforated liner with 120° phasing, total of 276 holes from 3,364' to 3,549'. Landed 2 3/8" production tubing at 3,647'.
