13. Describe Proposed or Completed Operation (clearly state all pertinent details including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleate horizontally, give subsurface locations and measured and true vertical depths or pertinent markers and sands. On 6/2/2003 work began to plug back the existing Mesa Verde and Dakota and complete the Pictured Cliffs interval of the subject well. Ran CBL log and identified TOC behind 5-1/2" casing at 3600'. Set cement retainer at 4600' and could not get injection rate below retainer. Per BLM, spotted 130 sx "H" cement on top of retainer and reversed out from 3450'. Split casing collar on 5-1/2" casing at 3407'. Pull and lay down 5-1/2" casing from 3407'. Attempt to pressure test 7-5/8" casing failed. Run CBL in 7-5/8" casing and identified TOC at 2050'. Found holes in 7-5/8" casing from 2022' to 1668'. Ran 5-1/2" casing back in well and cement w/ 405 sx "B" cement. When cement reached surface, closed casing valves and squeezed 125 sx cement into holes in 7-5/8" casing (no circulation through braidenhead). Pressure tested 5-1/2" casing to 4000 psi for 30 minutes. Perforated PC zone from 3284'-3361' and frac with 20/40 Brady sand and nitrogen assisted gel. Flowed well back and encountered excessive water production. Set cement retainer above bottom set of perfs at 3345' and pumped 25 sx "B" below retainer into perfs. Continued to clean well up and landed tubing at 3301'.
