On 6/30/2003 work commenced to remove the production liner from the subject well. Rigged up service unit and pulled rod string and production tubing. Tested 7" casing to 1500 psi for 30 minutes- solid test. Milled off top liner hanger and jarred liner out of wellbore. Cleaned fill to 3251' with coal running. Landed 2-3/8" production tubing at 3296' ( 157' off of PBTD and 11' off of fill). Turned well to sales producing the Fruitland openhole.
