Energen Resources plans to do the following to the Carracas 25A #14:

- ** Set an external casing style (open hole) packer inside the 6.25" open hole wellbore.
- ** Sting out of packer and spot 25 sks (29.5 cu.ft., 100% excess open hole volume 50 linear feet) Class B cement. Plugging procedure to allow FC infill well to be drilled in the NW quarter of S25.
- ** Verify top of plug and run liner according to APD and sundry procedure.
- ** Expected BHL to be 2600' FSL, 1608' FWL.
