Cement with 110 sks Class G, 2% CaCl2, 1/4#/sk floccle (130 cu.ft.). Plug down @ 1:00 pm on 08/27/06. Circulate 8 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
