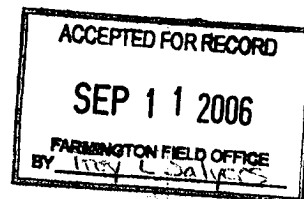

Cement with 225 sks Class B, 2% CaCl₂, 1/4#/sk floccle, 5#/sk gilsonite (266 cu.ft.). Plug down @ 6:00 pm on 08/31/06. Circulate 17 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
