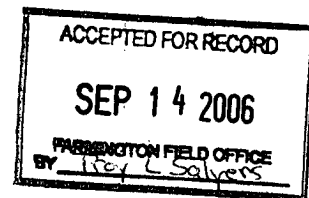

9/8/06. Circulate 60 bbls cement to surface. WOC. RD Halliburton. NU BOP.
Test casing & BOP to 1200 psi - ok.
