2/24/06: Spud well. Drill 12-1/4" hole to 318'. Run 8-5/8" 24# J-55 csg & set @ 318'. Cmt w/240 sx (283 cf) STD cmt w/2% CaCl₂ & 1/4# flocele. Circ 10 bbl cmt to surface. Pressure test csg to 1500 psi - OK.

Drill 7-7/8" hole to 3750'. 3/2/06: Ran 5-1/2" 15.5# J-55 csg & set @ 3750' w/FC @ 3720'. Cmted w/445 sx (872 cf) 65/35 POZ cmt w/10# gilsonite, & 1/2# flocele. Tail w/150 sx (219 cf) 50/50 POZ cmt w/3% gel, 0.5% Halad 9, 5# gilsonite, 0.2% CFR3, 0.2% Super CBL. Circ. 30 bbls cmt to surface. Plan to run CBL log & pressure test csg during completion operations.
