Drill 7-7/8" hole to 3791'. 3/9/06: Ran 5-1/2" 17# & 15.5# J-55 csg & set @ 3791'. Cmted w/445 sx (872 cf) 65/35 POZ cmt w/10# gilsonite, & 1/2# flocele. Tail w/150 sx (219 cf) 50/50 POZ cmt w/3% gel, 0.5% Halad 9, 5# gilsonite, 0.2% CFR3, 0.2% Super CBL. Did not circ. cmt to surface. Plan to run CBL log & pressure test csg during completion operations.
