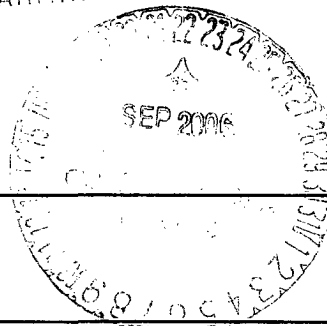

Scavenger 10 sx (32 cf - 5.7 bbls slurry). Tail 170 sx (201 cf - 35.7 bbls slurry) TYPE 5, w/3% CALC2 + .25 PPS CELLOFLAKE. Dropped plug and displaced with 16 bbls FW. Bump plug and circ 13 bbls cmt to surface. WOC. PT casing 600#/30 mins. Held OK.
