Lead 141 sx (300 cf - 54 bbls slurry) Premium Lite, Class TYPE III, CALC, CELLOFLAKE, LCM-1, FL-52, SMS. Tail 90 sx (124 cf - 22 bbls slurry) TYPE 3, Class TYPE III, CALC, CELLOFLAKE, FL-52. 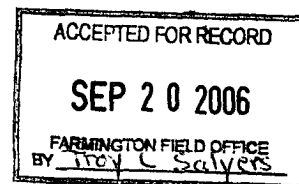
