Set CIBP @ 3635'. Tested PC perfs on 5/5/06 for 3 hours on 1/4" choke for 30 psi and 66 MCF/D. Land 2-3/8" tubing @ 3629'. Ran pump & rods. Released rig 5/9/06. Completed as a commingled PC/Tertiary gas well.

7/11/06. MIRUSU. TOH with 2-3/8" tubing. Using RBP & PKR, test Tertiary perfs - TSTM. Re-run 2-3/8" tubing and landed at 3621'. Re-ran pump & rods. Released rig 7/13/06.
