BLACK HILLS requests administrative approval to downhole commingle the East Blanco Pictured Cliffs (72400) and the Cabresto Canyon Tertiary (97037). Both intervals have common ownership & produce essentially dry gas. We have not experienced any significant cross flows between these two intervals & all the fluids are compatible. Downhole commingling will improve recovery of liquids & gas, eliminate redundant surface equipment and maximize productivity. Notice has been filed concurrently on form C-103 with the State.

The PC tested 66 MCF/D on 5/5/06. We plan to determine the allocation to both PC & Tertiary using the commingled on-line gas rate and the subtraction method.
