Cement with 150 sks Class G, 2% CaCl2, 1/4#/sk floccle (177 cu.ft.). Plug down @ 5:30 pm on 09/18/06. Circulate 12 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
