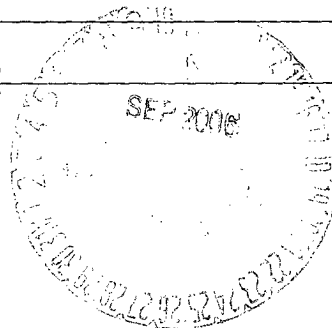

It is intended to drill this new Basin Fruitland Coal well to approximately 3973' (90' deeper than permitted), into the Pictured Cliffs formation. It is anticipated the Pictured Cliffs is not productive in this wellbore. A 5-1/2" 15.5# J-55 casing will be set and cement to surface. The Fruitland Coal interval will be perf'd, and stimulated.
