9/5/06 MIRU Key #29. PT casing 1500#/30 mins. OK. RIH w/6-1/4" bit and tagged on cmt @ 3400'. Circ hole with Air mist. Drilled out cmt from 3400' to 3514'. Drilled ahead to 3710' (TD) TD 9/6/06. Circ and condition hole w/N2 gas. TIH w/underreamer. Underream 6-1/4" open hole out to 9-1/2" FR 3520' to 3710'. Used energized & natural surges & RR'd to c/o for approx 6 day. POOH w/ bit. RIH w/ 5-1/2", 15.5#, J-55 LT&C casing (liner) & set bottom @ 3706' & top @ 3456' (overlap of 58' into 7" shoe). Liner Perf w/152 -.75" holes, 4-JSPF @ 3547' - 3551', 3567' - 3572' & 3581' - 3610'. All shots OK. RIH w/116 jts, 2 3/8", 4.7#, J-55 tubing and landed @ 3600' w/FN @ 3599'. ND BOP & NU WH. RD and release rig 9/15/05.

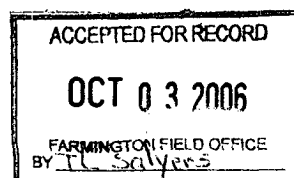
