In conjunction with previously approved Sundries of well work and DHC (DHC 1503AZ) of Basin Fruitland Coal (71629) and Blanco Pictured Cliffs (72359) Pools, Four Star Oil & Gas Company anticipates increases in production volumes necessitating installation and modification of existing surface production facilities. This includes replacing and up-sizing of the existing separator and meter run, installing a dual flow line, possible installation of artificial lift equipment, and installing a 400 Bbl water tank. Upon evaluation of resulting produced volumes and water capacity issues, a determination will be made of which tanks will be necessary for production purposes which may further result in removal of the existing FG 95 Bbl water tank. Currently there is one 2-phase separator, one FG 95 Bbl water tank and a meter run existing on location.

Your approval of this request to install and upgrade these surface facilities will enhance the environmental and economic capabilities of this well and lease.
