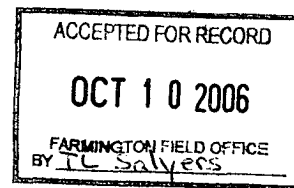

Pump 161 sx (202 cu ft - 36 bbl slurry) Type III cement w/ 3% CACL2, 0.25 pps celloflake. Did not circulate cement to surface. Tagged cmt @ 16'. Pumped 4 (22.5 cu ft - 4 bbl slurry) Type III cmt w/2% CACL2 @ 15.2 ppg thru 1" pvc jnt. Cement to surface. WOC NU BOP -test ok. PT csg to 600/30 min. Good test. Drill ahead.
