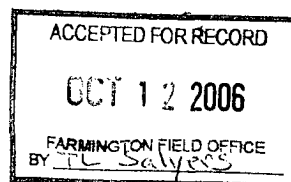

Cement with 150 sks Class G, 2% CaCl₂, 1/4#/sk floccle (177 cu.ft.). Circulate 8 bbls cement to surface. Plug down @ 7:00 pm on 10/03/06. RD Halliburton. WOC. NU BOP. Test casing & BOP to 600 psi - ok.
