Cement with 225 sks Class V, 2% CaCl₂, 1/4#/sk floccle (266 cu.ft.). Plug down @ 8:00 pm on 09/28/06. Circulate 49 bbls. cement to surface. WOC. RD Halliburton. NU BOP. Test casing and BOP to 600 psi - ok.
