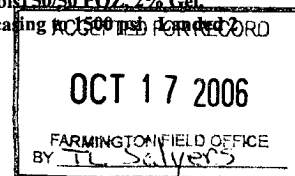

Drilled 12 1/4" hole to 325' on 9/13/06, set 7 jts of 9 5/8", H-40, ST&C, 32.3# casing at 316'. Cemented w/200 sx (42 bbls) Tail Class "G" cement w/2% CaCl and 1/4# Floeal. Circulated 15 bbls of cement to surface. Test casing to 2,000 psi.

Drilled 8 3/4" hole to 3,000' on 9/15/06, set 67 jts of 7", J-55 LT&C, 23# casing at 2,990'. Cemented lead w/500 sx (131 bbls) 50/50 POZ cement w/3% Gel, 5# Gilsonite, 1/4# Floeal, 0.1% CFR 3, 0.2% Halad 344 and tail w/75 sx (16 bbls) Class "G" cement w/0.4% Halad 344. Circulated 30 bbls of cement to surface. Tested casing to 2,000 psi.

Drilled 6 1/4" hole to 3,550' on 9/17/06, set 83 jts 4 1/2", J-55, LT&C, 11.6# casing at 3,537'. Pumped 290 sx (75 bbls) Foamed cement, followed by lead cement w/110 sx (28 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/75 sx (20 bbls) 50/50 POZ, 2% Gel, 4/10% Halad 9, 1/10% CFR3, 5# Gilsonite & 1/4# Floeal. No cement to surface, top of cement is at 450'. Tested casing to 1,500 psi. Loaded 2 3/8" production tubing at 3,452'.
