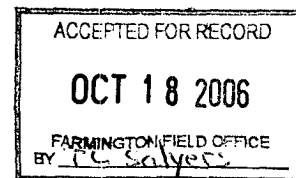

RIH w/underreamer and UR'd 6-1/4" hole to 9-1/2" from 2948' - 3188'. Circ. Hole. Started natural and energized surges. R&R & C/O with surges for approx. 13 days. 10/5/06 RIH w/7 jts of 5-1/2", 15.5# J-55 LT&C pre-perf'd casing (liner) and set @ 3188' w/TOL @ 2906' (32' overlap into 7" shoe). Perforations from 2972' - 3015'; 3057' - 3100'. RIH w/mill and M/O perf plugs. Circ. Hole. RIH w/102 jts 2-3/8", 4.7#, J-55 tbg and tagged fill @ 3165'. Circ. Hole w/mist & foamer. C/O to PBTD. P & Land tbg @ 3149' w/FN @ 3125'. ND BOP, NU WH. RIH w/rods & pump. Spaced out & PT. RD & released rig 10/7/06.
