RIG UP WIRELINE TO ATTEMPT TO SET BARRIERS IN TBNG. MADE IT TO 54' W/ 1.9" TOOLS. POH. RIH W/ 1.5" TOOLS. MADE IT IN TO 86'. RIG DOWN WIRELINE. ATTEMPT TO PUMP INTO FORMATION. STARTED W/ 425 PSI ON BACKSIDE. PUMPED 3.5 BBLs. AFTER PUMPING CASING PRESSURE @ 625 PSI.SWFN

Well flowing Saltwtr. Fluid Temp very hot; shut-in tbg pres 520 psi above full column water. Formations (PC & MV) appear to be damaged to point we can not inject into formations at safe pressure. May need another procedure to address flowing water. Rig Down move off location 10/24/06.
