8-7-03 Circ hole clean. TOOH. TIH w/5 jts 7" 20# J-55 ST&C csg, set @ 229'. Pump 2 bbl wtr, 3 bbl cmt ahead. Pump 104 sx Class "C" Type III cmt w/2% calcium chloride, 0.25 pps Celloflake (147 cu.ft.). (Setting casing & first cementing witnessed by John Coy, BLM). Circ 12 bbl cmt to surface. Displace to 198' w/8 bbl wtr. No returns on displacement. (Verbal approval to fill csg w/cmt from Wayne Townsend, BLM). TIH w/1" tbg to 32'. TOOH. Had contaminated cmt in csg. TIH w/1" tbg. Circ hole clean to surface. Pump 100 sx Type III cmt (157 cu.ft.) down csg. Circ 4 bbl cmt to surface. WOC.

8-8-03 NU BOP. PT BOP & csg to 600 psi/30 min, OK. Drilling ahead.
