5/16/05 MIRUSR. TOH w/2-7/8" liner. Re-ran 2-7/8" liner & landed @ MD 7060' w/ perfed subs @ MD 3900', 4700', 5200', 5900', 6700', & 7000'. Treated PC lateral w/300 gal. sodium Hypochlorite. Tested PC lateral on 6/1/05 on 1/4" choke for 3 hours @ 45 psi & 88 MCF/D. Released rig on 6/2/05.

3/22/06 MIRUSU. Cut 2-7/8" liner @ MD 3668' & TOH. (Window in 5-1/2" csg is @ 3648'-63'.) W/RBP @ 3570', pressure tested 5-1/2" csg to 750 psi-OK. Fish 5-1/2" whipstock & TOH. Cleaned out to 3760'. Landed 2-7/8" tbg @ 3712' in vertical hole. Ran pump & rods. Released rig 3/31/06. See attached wellbore diagram.
