Drilled 12 1/4" hole to 322' on 8/15/06, set 7 jts of 9 5/8", H-40, ST&C, 32.3# casing at 312'. Cemented w/200 sx (42 bbls) Class "G" w/2% Calcium Chloride, 1/4# Flocele. Circulated 14 bbls of cement to surface. Test casing to 2,000 psi.

Drilled 8 3/4" hole to 3,353' on 8/18/06, set 75 jts of 7", J-55 LT&C, 23# casing at 3,340'. Cemented lead w/500 sx (142 bbls) 50/50 POZ cement w/2% Gel, 2/10% Versaset, 1/10% FDPC766 and tail w/75 sx (19 bbls) 50/50 "G" POZ (tail) cement w/2% Gel, 2/10% Versaset, 1/10% FDPC766. No cement to surface, top of cement at 2,992'. Tested casing to 1,800 psi.

Drilled 6 1/4" hole to 7,784' on 8/22/06, set 173 jts 4 1/2", J-55, LT&C, 11.6# casing at 7,783'. Cemented w/485 sx (127 bbls) 50/50 POZ w/2% Gel, 5#/sx gilsonite, 1/10% CFR-3, 4/10% Halad 344, .25#/sx Flocele. No cement to surface, top of cement at 2,285'. Tested casing to 1500 psi. Landed 2 3/8" production tubing at 7,726'.

TOC for 7" casing = \pm 475 Ft per discussion w/ Devon. No
remedial action will be required.*
