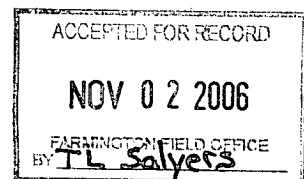

Cement with 60 sks Class G, 2% CaCl2, 1/8#/sk flocele (71 cu.ft.). Plug down @ 7:06 pm on 10/24/06. Circulate 5 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
