Pumped 57sxs(95cu-17bbls) Type 1-2 Portland cement w/20% flyash & 14.5 ppg into casing. Dropped plug and displaced w/7bbls FW. Circulated 0bbls to surface. WOC. Tag cmt in annulus @30'. Mixed 6sx(8cu-2bbls) Type 1-2 Neat cmt. Top out annulus to surface. Install wellhead. RD & MO. PT will be conducted by the drilling rig and shown on next report. 11/7/06
