Drilled 12 1/4" hole to 325' on 7/22/06, set 10 jts of 9 5/8", H-40, ST&C, 32.3# casing at 315'. Cemented w/200 sx (42 bbls) "G" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 11 bbls of cement to surface. Test casing to 750 psi.

Drilled 8 3/4" hole to 3,186' on 7/29/06, set 71 jts of 7", J-55 LT&C, 23# casing at 3,170'. Cemented w/575 sx (151 bbls) 50/50 POZ cement w/2% Gel, 5# Gilsontite, 1/4# Flocele, 0.1% CFR 3, 0.2% Halad 344 and tail w/50 sx (11 bbls) "G" cement w/0.4% Halad 344. Circulated 35 bbls of cement to surface. Tested casing to 1,500 psi.

Drilled 6 1/4" hole to 3,687' TVD on 8/14/06. Underreamed hole to 11" from 3,180' to 3,687'. Utilized natural and air assisted surges to remove near wellbore material. On 8/29/06, set 13 jts 5 1/2" 15.5, J-55 liner at 3,687' with liner hanger at 3,115'. Perforated liner with size 0.45" holes, 120° phasing, 4 SPF, total of 340 holes from 3,266' to 3,587'.
