Drilled 12-1/4" hole to 345'. On 6/16/2003 ran 8 jts 9-5/8" 36# K-55 casing and set at 338'. Cemented with 200 sx (42 bbls) Class "B" w/ 2% CaCl and 1/4# Flocele per sack. Circulated 15 bbls to surface. Pressure tested casing and BOP's to 250 psi and 1000 psi.

Drilled 8-3/4" hole to 2948'. On 6/20/2003 ran 69 jts 7" 23# J-55 casing and set at 2912'. Cemented with 600 sx (158 bbls) 50/50 Poz w/ 3% gel, 5 #/sx gilsonite, 1/4 #/sx Flocele, 0.1% CFR-3, and 0.4% Halad 344. Tailed in with 50 sx (10 bbls) Class "B" w/ 0.4% Halad 344. Circulate 56 bbls to surface. Pressure test casing to 300 psi and 1500 psi.

Drilled 6-1/4" hole to 3256'. Underreamed to 9-1/2". After cavitation was unsuccessful, ran 74 jts 5-1/2" 15.5# J-55 casing and set at 3247' on 7/14/2003. Cemented w/ 33 sx (10 bbls) San Juan Poz, followed by 150 sx (38 bbls) 50/50 Poz w/ 3% Gel, 0.2% CFR-3 and 0.4% Halad 344. TOC by CBL at 3170'. Pressure test casing to 1500 psi.
