Drilled 6 3/4" hole, on 8/10/03 ran 4 1/2", J-55, 10.5# LTC casing and landed @ 2252' KB. KB = 5'0"

Ran centralizers on the bottom 3 joints including shoe joint, and ran 2 turbulizers at the base of the Ojo and the 1st joint up in the Ojo. Cement with the following: Lead with 246 sks 12.5# Class B Cement, with 2% Sodium Metasilicate, .25#/sk Cello Flake, 3 pps Gilsonite, and 1.62 pps Phenoseal, yield 2.12. Tail with 60 sks 14.5# Class B cement with 4% gel, 2% CaCl2, .25#/sk Cello Flake, yield 1.55. There was celloflake returns during the last 15 bbls of displacement and a trace of cement, bump plug @ 1000#, plug held. Will run CBL and GSL logs at a later date. Move Rig
