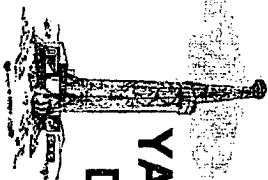

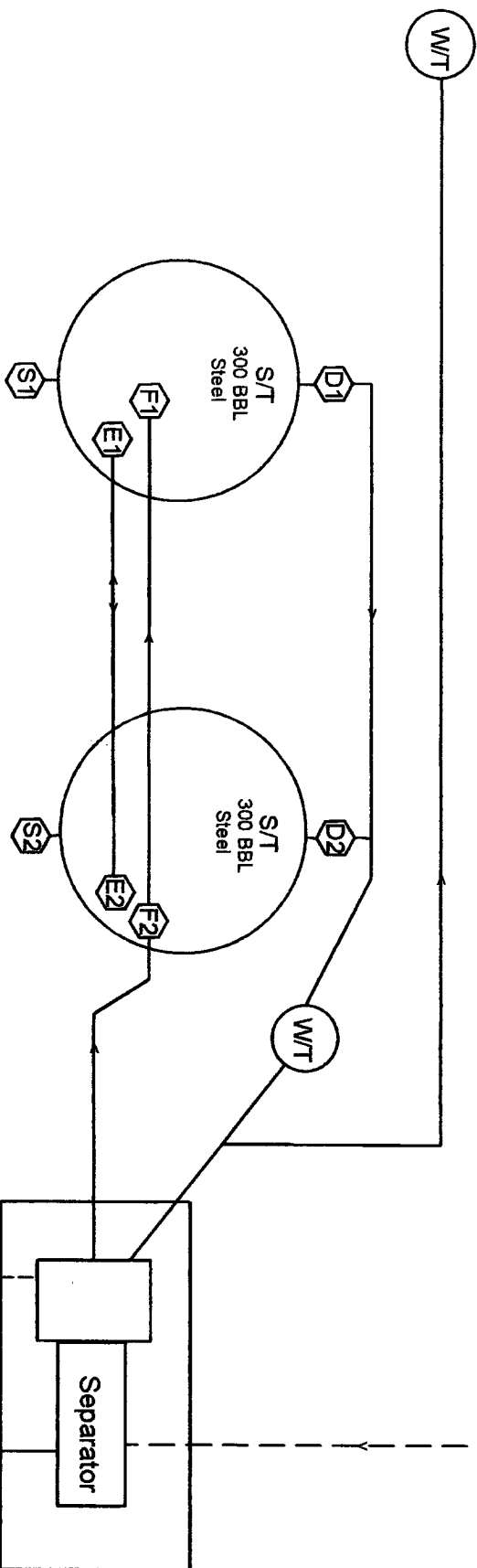

**Production phase.** All drain valves, D1 & D2, and all sales valves, S1 & S2, sealed & closed.

**Sales phase.** The tank from which sales are being made will be isolated by sealing closed the drain valve, fill valve and the equalizer valve during sales.

**Draining phase.** The tank being drained will be isolated by sealing closed the sales valve, fill valve, equalizer valve and the drain valves on the other tanks.
