**Drilled 6 1/4" hole to 8,396' on 10/11/06, set 199 jts 4 1/2", J-55, LT&C, 11.6# casing at 8,390'. Cemented lead w/200 sx (52 bbls) foamed 50/50 V POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/600 sx (188 bbls) non-foamed Dakota Lite w/3#/sx Phinoseal, 1% Halad 9, 2/10% HR5. No cement to surface. Tested casing to 1000 psi.**

**On 10/31/06, 6 squeeze perforations were shot at 6,040'. 260 sx of V POZ cement was pumped w/2% Gel, 5#/sx Gilsonite, 1/8#/sx Polyflake, .2% CFR-3, & 1% Halad-9. Top of cement is at 2,970', determined from the CBL ran on 11/3/06.**
